The Commonwealth Secretariat is pleased to host the Launch of a Policy Guide on National Agricultural Data Infrastructure (NAgDI), an approach to delivering Digital Public Infrastructure (DPI) for agricultural data management at country level as part of its Commonwealth Connectivity Agenda for Trade and Investment (CCA) programme.

The agricultural sector is at the heart of food systems transformation agenda across the Commonwealth. The sector is ripe for digital transformation but requires robust data infrastructure at national level to effectively address the challenges it faces. Investing in data infrastructure offers private sector investors the opportunity to play a crucial role in building the backbone of modern agriculture in the global south, tap into dynamic and evolving markets, and gain better access and insights into market trends.

This event will raise awareness on the opportunities that are available with the launch of the Guide and provide a platform for stakeholders to engage with the Commonwealth on strategies to translate the content of the Guide into actions in member countries.

Dr Ruth Kattumuri Senior Director, Economic Development, Trade and Investment Directorate (EDTI), Commonwealth Secretariat

Dr. Ruth Kattumuri is a Senior Diplomat and Academic. With over thirty years of global experience spanning teaching, research, technical assistance, capacity building and policy influence. She provides strategic, technical and thought leadership for economic resilience and sustainable development. Her expertise spans innovation and technology, entrepreneurship, climate finance, and international development. She holds a PhD from LSE, is a Fellow of the Academy of Social Sciences, and is a Cambridge Commonwealth Fellow. She was awarded the Mahatma Gandhi Pravasi Samman Award in recognition of her contributions to inclusive development.



Mr Dreli Silas Solomon Chargé d'Affaires, Embassy of the Republic of Vanuatu

Dreli Solomon is a diplomat from Vanuatu, currently serving as the Chargé d'Affaires of the Republic of Vanuatu High Commission in Brussels, Belgium. In his diplomatic role, he represents Vanuatu in its relations with the European Union and other accredited countries and multilateral organisations. Mr. Solomon has been a speaker on international platforms, including discussions related to climate change and the initiative to advance the recognition of ecocide in international law, demonstrating his involvement in key global issues for the Pacific nation.



Dr Celso Luiz Moretti CEO, OpenAg Foundation

He is a results-oriented leader with a global vision, with over 30 years of experience in agribusiness. With a degree in agronomy and an MBA, master's degree, and doctorate in food production, Moretti served as President of the Brazilian Agricultural Research Corporation (Embrapa, Brazil) from 2019 to 2023, where he led a team of 8,000 employees, including 2,100 PhD researchers, distributed across 43 research centres in Brazil. He is an alumnus of the Harvard Kennedy School (USA) and Visiting Associate Professor at the University of Florida (Gainesville, USA) since 2006. Celso is recognised for his strategic leadership and commitment to sustainability and innovation in the Brazilian agricultural sector. He is the incoming Chair for the Consortium of International Agricultural Research Centres (CGIAR).



Mr Ville Sirviö CEO, Nordic Institute for Interoperability Solutions (NIIS)

Ville Sirviö is the CEO of the Nordic Institute for Interoperability Solutions (NIIS), where he leads the development of X-Road® open-source software, used by hundreds of millions of people worldwide. With a diverse background spanning startups to listed companies, he has led organisations specialising in software development, digital commerce, SaaS platforms, digital government, interoperability, and open-source software. He has served on several boards and advisory groups, including the Gaia-X European Association for Data and Cloud, the European Commission's Informal Expert Group on the Next Generation European Interoperability Framework, and the United Nations DPI Safeguards Strategic Advisory Board.





Mr Lars Kahnert

Advisor Digitalisation, GIZ / DIASCA

Lars Kahnert is an advisor on digitalization within the GIZ Sustainable Agricultural Supply Chains Initiative (SASI). He is steering DIASCA, fostering DPI in agriculture. Earlier, he initiated the open-source traceability solution INATrace. Prior to joining GIZ in early 2019, Lars worked with the Global Coffee Platform and the 4C Association for 12 years. Here, he has led projects to establish data standards for coffee and cotton, carbon foot printing, pesticide management, and access to finance. Earlier, Lars worked in international development in South Asia, Africa and Germany. He holds a degree in Geography and Indian Philology from FU Berlin.
